3. Accordance with Silpakorn University's 2007 Regulations on Graduate Study and/or later revision (see Appendix A) and/or updated amendment.

Other qualifications may also apply as reviewed by Committee of Faculty of Pharmacy.

For **doctoral students**, it is required to have English language test results comparable to the CEFR criteria at one of the levels (*unless the course specifies higher English proficiency criteria set by Silpakorn University*). (*Please specify additional information*)
